DEFENCE/SECURITY

Pakistan, China, and Afghanistan met in Beijing to discuss restoring diplomatic ties between Pakistan and Afghanistan. They emphasized security cooperation against militants and expanding China-Pakistan projects into Afghanistan. Pakistan remains cautious about Afghanistan's growing ties with India but welcomes China's role in promoting regional stability.

Pakistan will appoint an ambassador to Afghanistan for the first time since the Taliban took power in 2021. This follows a recent high-level meeting in Beijing, where China hosted foreign ministers from both countries to boost regional ties and increase its influence in South Asia.

Pakistan's economy is showing cautious recovery with improved manufacturing, strong remittances, easing inflation, and better agricultural output supporting growth. Fiscal discipline, social programs, and sustainable development initiatives like Green Sukuk further bolster optimism despite geopolitical challenges.

Ceasefire holds as India and Pakistan tensions shift-to-diplomacy. aiming to reduce Pakistan's steel import deficit by 30% and boost local employment. This deal, coming amid heightened India-Pakistan tensions, marks a deepening of Russia-Pakistan ties and reflects Russia's neutral stance in the ongoing regional conflict.

India has approved the development of its first indigenous stealth fighter, the AMCA, to counter China's J-20 and Pakistan's incoming J-35A jets plan.

Pakistan has launched its first government-backed Bitcoin reserve and national wallet, supported by new regulations and surplus electricity for crypto mining, marking a major step into the digital economy. This initiative aims to boost blockchain innovation and financial inclusion under the guidance of Special Assistant Bilal Bin Saqib.

Pakistan and Azerbaijan discussed boosting defense ties and regional security, with Azerbaijan showing support for Pakistan amid India tensions. Pakistan's army chief also met Iranian officials to enhance border security and trade. Meanwhile, Prime Minister Shehbaz Sharif is on a regional tour to strengthen diplomatic and economic relations.

Pakistan's PM Shehbaz Sharif and Army Chief Asim Munir are touring regional allies to strengthen ties and counter India's claims amid recent tensions. The trip focuses on diplomacy, defense cooperation, and promoting peace.

U.S. ramps up its military footprint in Australia as tensions with China rise. The U.S. is expanding its military presence in northern Australia as it looks to project power and provide a deterrence against the increasing threat of China in the Asia-Pacific.

US-Australia relationship "strong as ever", says Hegseth as he meets Deputy PM. US Defence Secretary Pete Hegseth has called the alliance with Australia as "strong and robust as it has ever been", as he met Deputy Prime Minister Richard Marles in Singapore.

Australia will keep pushing US to drop Trump tariffs after court ruling, trade minister says. Don Farrell says the government has been consistent in its view that tariffs on Australian imports to the US are unjustified

New report slams long-term defence budget. A new report warns Australia will be unprepared for near-term conflict due to the government's focus on future military capabilities.

'Paper ADF': Dire warning to Australia. Australia must boost its immediate readiness to go to war or risk having a "paper ADF", a leading defence think tank warns.

AUKUS in space: Morrison proposes 'Pillar 3' for pact. Scott Morrison has proposed expanding the AUKUS security partnership through a 'Pillar 3' initiative that he says will enhance deterrence and make Australia a more valuable ally.

Investing in the Australian Defence Force's cyber warfare workforce. As part of Defence's transition to an integrated and focused force, cyber warfare personnel will now have multiple career pathway opportunities within Defence. The transition to a new skills-based pay structure will help Defence build a fit-for-purpose cyber warfare workforce.

Australia awards \$16.5 million in defence grants. The Australian government has awarded grants to more than 50 businesses across the country that provide priority defence capabilities with the funding supporting hundreds of jobs and a future made in Australia.

Australia to host Republic of Fiji Military Forces company. Australia and Fiji are strengthening their Defence partnership through a rotation of Republic of Fiji Military Forces (RFMF) personnel spending the next five months in Australia.

Combat Systems Micro-credentials launched to strengthen Australia's defence capability. South Australia's Deputy Premier, Susan Close MP, has officially launched Australia's first suite of credit-ready Combat Systems Engineering Micro-credentials, marking a major step in upskilling the national workforce to enhance Australia's defence capabilities.

China's Jiu Tian UAV is a high-altitude drone that carries and launches swarms of smaller attack drones, extending the PLA's strike range. It represents a new approach to swarm warfare and could potentially overwhelm defenses.

Japan Enhances Anti-Drone Capability with Mobile Laser Weapon at DSEI 2025. The development of Japan's directed energy weapon (DEW) system is advancing steadily, reflecting Tokyo's commitment to next-generation defence technologies. Presented at DSEI Japan 2025, the prototype, known as the "Vehicle-Mounted High-Power Laser Demonstration System," represents a step forward in the country's efforts to address emerging aerial threats, particularly drones.

Europe-Japan GCAP fighter racing against China's rising air power. The UK, Japan and Italy are turbocharging their sixth-generation Global Combat Air Program

(GCAP) stealth fighter ambitions in a race to outpace China's fast-rising and now battle-proven airpower.

Japan scrambles jets as China conducts Carrier Aircraft Operations in East China Sea. In a massive show of force, the Chinese aircraft carrier "Liaoning" was seen conducting aircraft & helicopter takeoff and landing operations close to the Japanese coast in the East China Sea. The Japanese Ministry of Defence said that Air Self-Defence fighters had been scrambled in response, though there was no reporting of violations of Japanese airspace.

Handover Ceremony of OSA (Official Security Assistance) FY2023 Project for the Republic of Fiji. On May 26, 2025, at the Stanley Brown Naval Base located in Suva, the capital of the Republic of Fiji, the Handover Ceremony for OSA (Official Security Assistance) was held, with the attendance of Mr. TAKADA Isami, Chargé d'Affairs ad interim of Japan to the Republic of Fiji.

Japanese Navy Advances with AI-Driven Uncrewed Surface Vehicle for Autonomous Operations. Mitsubishi Heavy Industries (MHI), in partnership with Japan's Acquisition, Technology & Logistics Agency (ATLA), revealed the development of a new AI-enabled uncrewed surface vehicle (USV) designed for multipurpose combat support.

ICEYE and IHI unite to bolster Japan's satellite prowess. The Polish-Finnish company ICEYE has entered into a collaboration with the Japanese company IHI Corporation, which specialises in heavy industry. The aim is to create a constellation of SAR satellites for both civilian and military use.

South Korea Mulls Replacing Delayed Aircraft Carrier Program with Drone Carrier. SBS, a major Korean news outlet, recently reported that the Republic of Korea Navy (ROKN) is reviewing plans to refloat the program by turning the vessel into a drone carrier.

South Korea begins KF-21 Boramae fighter jet assembly marking shift in global defense market. South Korea's Defense Acquisition Program Administration

(DAPA) announced that the country had begun final assembly of the first mass-produced KF-21 Boramae multirole fighter aircraft.

Joint Ground Forces Engineer-Troops Training Exercise Taking Place in South Korea. The first independent Joint Ground Forces Engineer-Troops Training Exercise is being organized from May 19 to May 30, 2025. The exercise aims at expanding defense relations and cooperation between Mongolia and the Republic of Korea and enhancing the capacity of the two countries in United Nations peacekeeping operations.

North Korea detains four officials over failed launch of naval destroyer. North Korea has detained four officials who it says are responsible for the failed launch of its second naval destroyer, which outside observers say was damaged much more than the country has disclosed.

Pakistan, US deepen security engagement through Anwar-Hegseth meeting. Prime Minister Anwar met US Defence Secretary Hegseth and Boeing's chief in Singapore. The discussions focused on expanding defence cooperation and strengthening strategic ties.

France honours Prabowo with highest military award. French President Macron awarded Defence Minister Prabowo France's highest military honour. The move highlights deepening defence and strategic ties between France and Indonesia.

US defence chief seeks stronger Asian security ties. US Defence Secretary urged Asian allies to enhance cooperation amid rising China tensions. He emphasized US commitment to regional stability at the Asian security forum.

Defence in focus as RI-France eye future cooperation. France and Indonesia discussed future joint military production and technology sharing. Talks aim to elevate the bilateral defence partnership to a strategic level.

US pushes Australia to raise defence spending. Washington is pressuring Canberra to boost its defence budget in line with NATO levels. The US argues that increased spending is essential amid growing Indo-Pacific threats.

US defence chief urges Asia to match Europe's 5% defence spending. Pete Hegseth called on Asian countries to spend 5% of GDP on defence. He cited European examples and growing regional threats to justify the call.

Singapore hosts defence ministers' meeting. Singapore hosted defence leaders from Five Power Defence Arrangements and others. The meeting addressed multilateral defence cooperation and regional security strategies.

China expands naval strike capabilities. China has upgraded its destroyers with airborne early-warning systems. This significantly extends its maritime strike range and surveillance capability.

What Macron's visit means for Indonesia's defence future. Macron's visit indicates French interest in Indonesia's defence market and capabilities. It may lead to enhanced cooperation on military technology and joint projects

North Korea in 'strongest strategic position' in decades, U.S. intel report says. North Korea stands in its "strongest strategic position" in decades, a U.S. intelligence report showed, as the recalcitrant regime has been doubling down on its pursuit of advanced weapons that can threaten U.S. forces and allies in Northeast Asia and the U.S. mainland.

Japan Eyes K-RACER Drone to Tackle Military Logistics Challenges. According to information published by the Australian Defence Magazine (ADM) on May 27, 2025, Kawasaki Heavy Industries (KHI) is in advanced discussions with Japan's Ministry of Defence regarding the possible acquisition of the K-Racer autonomous transport drone.

Europe welcomes Japan's shift to non-US arms suppliers. European defence companies indicate that Japan has been rapidly opening its doors to non-American military equipment suppliers since the election of US President Donald Trump.

North Korea warns Trump's Golden Dome missile shield could 'turn outer space into a nuclear war field'. North Korea has issued a quick and strong response to US President Donald Trump and his plans for a proposed "Golden Dome", insisting it could make outer space a "nuclear war field".

North Korea's state security minister to attend high-level meeting in Russia, KCNA says. North Korea's minister of state security, Ri Chang Dae, left Pyongyang on Monday to attend a meeting of senior security officials in Russia, the North's KCNA state news agency reported.

North Korea Unveils New Air-to-Air Missile and Aerial Bombs. North Korea has revealed a new air-to-air missile that shows significant progress in its military technology. On May 15, 2025, during a live-fire drill, the missile was tested, where a MiG-29 fighter jet successfully launched it under the watchful eye of North Korean leader Kim Jong Un.

US Congress's think tank raises estimate for size of North Korean nuclear arsenal. North Korea has produced enough fissile material to build up to 90 nuclear warheads, and may have already assembled approximately 50 of them, according to a new report by the U.S. Congress's think tank.

Bangladesh to procure 6 improved KSS-I submarines from South Korea to protect its maritime territory. According to BDMilitary on May 21, 2025, the Bangladesh Navy is engaged in advanced negotiations with South Korea for the acquisition of six Improved Jang Bogo-class submarines under a defence procurement program valued at approximately \$2 billion.

South Korea to Supply Composite Armour to Boost Protection of Türkiye's Altay Tank. South Korea's Samyang Comtech officially secured export approval to supply advanced ballistic armour for Türkiye's Altay main battle tank. As reported

by South Korea's Defence Acquisition Program Administration (DAPA), this marks the company's first direct international armour contract for a foreign-developed tank.

Japanese GSDF Conducting Live Fire Anti-Ship Missile Drills. Japan's Ground Self-Defence Force's First Artillery Brigade publicly announced it will be conducting live-fire training exercises employing its truck-mounted Type 88 long-range surface-to-ship missile systems over the period June 19 to 30, 2025.

Honeywell Strengthens Position in Japan's Defence Market with Advanced F124 Turbofan Engine. Honeywell announced its advanced F124 turbofan engine is being proposed for several key programs that support the modernisation of the Japan Air Self-Defence Force's fleet, expanding Honeywell's presence in Japan's defence market.

Lockheed Martin, Fujitsu Limited agree to MOU for SPY-7 component. US contractor Lockheed Martin and Japanese company Fujitsu Limited confirmed in a release that they had reached a memorandum of understanding (MOU) establishing Fujitsu as a source for the SPY-7 Subarray Suite Power Supply Line Replaceable Unit (PS LRU).

Japan eyes US defence gear purchase ahead of another round of tariff talks. Japan is considering using the purchase of U.S. defence equipment as a bargaining chip in tariff talks, its top tariff negotiator Ryosei Akazawa said on Thursday as he heads for a fourth round of the negotiations in Washington.

Japan in Talks to Procure Kawasaki K-Racer Drone for Military Logistics. Japan's Ministry of Defence is in talks with Kawasaki Heavy Industries (KHI) over the potential acquisition of the K-RACER drone to support military logistics missions.

Australia's defence minister Marles to meet US, Japan counterparts. Australia's Defence Minister Richard Marles will meet with his U.S. and Japanese counterparts at an Asian security forum in Singapore, the first trilateral talks since elections in Australia and the Trump Administration took office.

North Korea replaces senior military officials at party meeting. North Korea has replaced senior military officials, including directors of the armed forces' artillery and security bureau, during a meeting of the ruling party's central military commission, state media reported.

Hanwha to boost South Korea missile defence with K-THAAD MFR. Hanwha Systems has entered into a contractual agreement with the Agency for Defense Development (ADD) of South Korea to build an advanced Multi-Function Radar (MFR) for the L-SAM-II system, also known as 'South Korea's K-THAAD'.

British engines to power South Korean warships. Rolls-Royce has announced that its MT30 marine gas turbines will power the Republic of Korea Navy's next generation of Ulsan-class frigates.

Russia provided North Korea with air defense system: Seoul. Russia has provided North Korea with an air defense system and other military support since late last year, according to an international monitoring report released Thursday by South Korea's Foreign Ministry, Yonhap News reported.

North Korea accuses US of posing a threat to global peace, security. North Korea has accused the US of posing a threat to global peace and security through unilateral and militaristic hegemonic policies, state-run media.

North Korea and Russia's vice ministers discuss cooperation in Pyongyang. Russia's Vice Minister of Internal Affairs Vitaly Shulika and Ri Song Chol, North Korea's vice minister of public security, held a meeting to discuss expanding cooperation and exchange, state media reported.

Japan Minister of Defense Calls on Minister for Defence for Singapore. Japan Minister of Defense Nakatani Gen called on Minister for Defence Mr Chan Chun Sing at the Shangri-La Hotel on the sidelines of the 22nd Shangri-La Dialogue (SLD).

Japan ramps up F-35 force posture. The Japan Air Self-Defence Force (JASDF) has strengthened the force posture along its northern coastline by initiating the

deployment of new Lockheed Martin F-35A Lightning II fifth-generation fighter aircraft to Komatsu Air Base in Japan's main island of Honshu.

Hegseth calls North Korea ‘formidable threat’ as USFK role set to broaden. US Defence Secretary Pete Hegseth warned Saturday that North Korea poses a formidable threat to the Indo-Pacific region, as senior military voices suggest American forces in South Korea may need to prepare for a broader regional role.

Macron to China: Keep North Korea out of Ukraine war or risk NATO coming to Asia. French President Emmanuel Macron warned China that NATO could become more deeply involved in Asia if Beijing does not do more to stop North Korea from taking part in Russia's war on Ukraine.

Russia has provided N. Korea with Pantsir air defense system, jammers since troop deployment: report. Russia has provided North Korea with its air defence system, electronic warfare jamming devices and other military support since late last year, in blatant violations of UN sanctions amid their deepening ties, an international monitoring report released by Seoul’s Foreign Ministry showed.

North Korea Conducts Nuclear Strike Drill. North Korea conducted missile drills simulating a nuclear counterstrike against U.S. and South Korean forces after criticizing the United States for conducting a drill that simulated a North Korean nuclear strike on the U.S. homeland.

Political scientist Andrew Nathan told Nikkei that if U.S. policies under President Trump weaken America, China might feel compelled to fill the resulting power vacuum. However, he noted that Beijing does not currently have a fixed ambition to become the world's leading power.

U.S. defense Secretary Pete Hegseth, in a landmark speech at the Shangri-La Dialogue, warned of an “imminent” military threat from China. He emphasized that deterrence through strength is crucial while cautioning Indo-Pacific nations against balancing ties between Washington and Beijing.

The U.S. plans to offer India a customized F-35A stealth fighter to counter rising Chinese and Pakistani airpower. As China fast-tracks J-35A jets to Pakistan, India views the F-35 as vital for deterrence, while also weighing Russia's Su-57E co-production offer amid growing geopolitical competition.

India now plans to buy the more advanced S-500 system, which can target hypersonic missiles and satellites. However, purchasing the S-500 risks US sanctions under CAATSA, making the decision complex.

India is engaging with defence manufacturers from the UK, France, and Japan to co-develop fighter jet engines, aiming to enhance its defence capabilities amid rising regional tensions. This effort complements India's indigenous stealth fighter program (AMCA) and reflects a push for technology transfer and self-reliance, following recent aerial clashes with Pakistan and challenges in procuring engines from the US.

India's defence production hit a record ₹1.46 trillion in 2024-25, with exports rising over 14% to ₹24,000 crore, driven by increased private sector participation and the launch of the AMCA stealth fighter program. Full utilization of the modernisation budget and historic contract signings underscore India's push for self-reliance and military upgrade.

India is collaborating with defense manufacturers from the UK, France, and Japan to co-develop fighter jet engines. It is aiming to strengthen its defense capabilities amid rising regional tensions.

India is reviving the Kailashahar airfield in Tripura to counter China's development of Bangladesh's nearby Lalmonirhat airbase, securing the vulnerable Siliguri Corridor. This move enhances both civilian connectivity and military readiness amid growing India-China regional tensions.

Indonesia reportedly considering buying Chinese and Russian fighter aircraft. The procurement would reportedly include dozens of J-10 fighters modified in China, while resuming a stalled deal to purchase Su-35 fighters from Russia.

Russia ranks among top five global arms exporters – Putin. The president has called for an expansion of the range of services in the industry.

Trump’s trade offer led to India-Pakistan ceasefire – White House. The US commerce secretary has said the truce between the two South Asian nations happened due to the president’s intervention.

India surpasses Japan as fourth-largest global economy – New Delhi. The South Asian nation's economy has grown to \$4 trillion, surpassed only by the US, China, and Germany.

Indian Army shows off locally manufactured drones (VIDEO). The South Asian nation's military has showcased its homegrown UAVs after its recent clash with Pakistan.

India clears way for own fifth-generation fighter jet. New Delhi has granted approval for developing a stealth aircraft as it pivots toward reducing dependence on defense imports.

Indonesia showcases new domestic defence products at Indo Defence 2025 Expo. The event, featuring 1,180 companies from 55 countries, is a platform to secure global partnerships and enhance multilateral relations. Defence Minister Sjafrie Sjamsoeddin expects multiple cooperation contracts to be signed between local and foreign manufacturers.

Malaysia and Türkiye have expanded their defence cooperation by signing two MoUs. The agreements focus on the joint development of naval platforms and the co-production of tactical mini UAV systems, aiming to enhance Malaysia's domestic defence industry and sovereign capabilities.

ECONOMY

Australian Economy Braces for Shifts From US-China Trade Dynamics. Australia's economic scene is in flux as the central bank eyes policy shifts due to US-China trade tensions and leadership changes at big mining firms.

Australia Floods Recovery Could Take Several Months, PM Says. It could take several months to get back to normal life due to devastation of floods.

China is spearheading a new economic bloc with ASEAN and GCC nations to counter U.S. protectionism, aiming for deeper trade, infrastructure, and financial

cooperation. Premier Li Qiang highlighted the bloc's strategic potential amid global tensions, with analysts viewing it as a step toward a possible “Asian Union.”

A U.S. court has blocked former President Trump’s “Liberation Day” tariffs, ruling he overstepped his authority, offering only temporary relief to China and other nations. Though the administration has appealed, analysts warn Trump could still reimpose tariffs through alternative legal channels.

China and Europe’s semiconductor leaders met in Beijing to strengthen collaboration and boost supply-chain resilience amid increasing U.S. tech restrictions on China. Both sides emphasized safeguarding global semiconductor stability and rejected unilateral trade practices, pledging deeper cooperation and a fair business environment.

Indonesia aims for EU trade progress amid softened green rules. Jakarta sees opportunity as the EU eases its green regulations. This may help Indonesia achieve breakthroughs in CEPA negotiations.

China’s GEM invests \$8B in Kalimantan battery hub. Chinese firm GEM will build a global battery recycling facility in Kalimantan. The \$8 billion investment supports Indonesia’s green industry ambitions.

ASEAN seeks unified front in US tariff talks, expands China ties. ASEAN plans to approach US tariff negotiations collectively. Simultaneously, the bloc is strengthening economic engagement with China.

China debt pressures mounting on developing nations. A report warns of unsustainable debt burdens from Chinese loans. Low transparency and high interest rates are worsening financial stress.

RI consumers cutting back amid economic strain. Indonesians are trading down to cheaper goods due to rising living costs. Economic pressures are changing consumer behaviour across sectors.

Manpower Ministry bans age limits in job ads. Indonesia has banned age restrictions in recruitment postings. The move aims to reduce employment discrimination and improve job access.

Malaysia, Vietnam to finalise digital economy MoU. Both countries aim to sign a digital economy MoU by August. The pact will focus on innovation, tech exchange, and digital trade.

Malaysia's Economy Minister attends ASEAN Summit. Minister Rafizi represented Malaysia at the 46th ASEAN Summit. He engaged in regional talks on economic growth and digital integration.

ASEAN-China-GCC ties seen boosting global economic certainty. Closer ASEAN-GCC-China ties are expected to stabilize global markets. Experts believe the tripartite relationship enhances economic resilience.

BRICS adopts climate finance framework. BRICS countries have agreed on a joint stance for climate funding. This marks the first unified framework for sustainable development finance.

Indonesia-France sign equestrian sports cooperation deal. The deal aims to develop equestrian sports and training programs. It is part of broader cultural and economic collaboration efforts.

Brunei ranks fifth in Malaysia's tourist arrivals. Brunei remains a top tourist source for Malaysia. Tourism links continue to strengthen bilateral economic exchanges.

India's economy grew 7.4% in Q1 2025, led by construction and manufacturing. While global tariff uncertainties pose risks, strong domestic demand and easing inflation are expected to support future growth.

China and Japan made progress in talks to resume Japanese seafood exports to China, but the import ban on some products remains until Japan meets China's safety and monitoring requirements.

India's image as a rising democracy and global power is largely built on disinformation, not institutional strength. From manipulating Kashmir narratives to using media, fake operations, and Bollywood propaganda, India systematically distorts facts to vilify Pakistan and shape global opinion in its favor.

India is pushing to finalize an interim trade deal with the U.S. by June 25 to mitigate tariff risks and boost exports. The agreement could open access to key sectors and enhance bilateral trade, aiming for \$500 billion by 2030.

Israel expects to finalize several economic agreements with India this year, focusing on fintech, investment stability, and innovation-driven sectors, while a full FTA may take more time. Despite regional challenges, Israel forecasts 4% GDP growth, citing strong economic fundamentals and resilient investor confidence.

New Zealand will not be 'guilt-tripped' over environment, resources minister says. Shane Jones is unapologetic about his plan to double mineral exports to \$3bn over the next decade despite criticism over potential environmental impacts

RBNZ Set to Make Sixth Rate Cut and Signal Bias to More Easing. New Zealand's central bank is set to cut interest rates for a sixth straight meeting and signal it's open to further easing as US trade barriers dim the economic outlook.

Trade negotiations between Indonesia and the United States remain uncertain ahead of a key deadline. Jakarta is awaiting Washington's response to proposals aimed at averting significant US import tariffs. A failure to reach an agreement could see the U.S. impose a 32 percent "reciprocal" tariff on Indonesian goods.

Malaysia attracted RM89.8 billion in approved investments in the first quarter of 2025, a 3.7% year-on-year increase. The investments span 1,556 projects across manufacturing, services, and primary sectors and are expected to create over 33,300 new jobs, reflecting continued investor confidence despite global economic challenges.

Envoy for free trade deal to boost Pak-South Korea ties. Stressing the importance of a Free Trade Agreement (FTA) between Pakistan and South Korea, Ambassador of the Republic of Korea, Park Kijun, on Friday said that such an arrangement could significantly strengthen bilateral trade and economic cooperation.

China's ambassador hits out at Australia's 'questionable' Darwin Port return plan. Xiao Qian says Landbridge Group, which has a 99-year lease, has made significant investments in the port and contributed to the local economy.

Norwegian princess moves to Australia for university. Norway's Princess Ingrid Alexandra is moving to Australia for her university studies, enrolling in a degree programme at the University of Sydney.

Indonesia is planning to send its pilots to China for J-10C fighter jet training, suggesting a potential acquisition of 42 aircraft. This action reflects Jakarta's strategy to diversify its airpower by incorporating platforms from China, Russia, and France amidst rising regional tensions.

China hosted Pacific Island leaders in Xiamen to strengthen ties and weaken Taiwan's diplomatic influence in the region. The meeting included representatives from Beijing-friendly Pacific countries amid growing geopolitical competition.

China has expanded its military presence in the Indian Ocean to secure trade routes and strengthen regional ties, prompting India and the U.S. to increase naval activities. This growing footprint challenges India's dominance and signals a more assertive Chinese naval posture in the region.

Japan has been allowed by India to inspect debris from China's PL-15 missile, offering rare insight into its advanced technology. The move highlights growing regional concerns over China's airpower.

China launched the International Organization for Mediation (IOMed) in Hong Kong on Friday, with 32 signatory countries and support from over 80 nations and 20 international organizations. The move comes as U.S. unilateralism under Trump's "America First" policy challenges traditional global frameworks.

In a bid to support the struggling economy, the central bank also delivered a quarter-point base rate cut.

Japan says progress has been made in U.S. tariff talks. Japan's chief trade negotiator Ryosei Akazawa said progress was made toward reaching a deal during

his fourth round of tariff talks with his American counterparts, but declined to provide specifics.

Japan, US To Hold New Round of Trade Talks Before G7 Summit. Japan and the US agreed on Friday to hold another round of trade talks before next month's G7 summit, with Japan's top tariff negotiator emphasizing that any deal must include concessions on all American tariffs, including those on automobiles.

Ishiba, Cambodian Leader Affirm Economic Cooperation. Prime Minister Shigeru Ishiba and his Cambodian counterpart, Hun Manet, met in Tokyo on Friday and issued a joint statement announcing an economic cooperation package.

Mineral desire: Moscow has enough to satisfy India. With global power dynamics shifting and Arctic resources surfacing, New Delhi has a timely chance to deepen ties with Russia.

Asian security officials to convene in Moscow. The delegations are among over 100 attending a Russia-hosted forum on cyber and regional security.

Russia and China agree on Putin-Xi talks agenda. Russia and China have begun work on a program of talks between the leaders of the two countries, which will take place in September. Deputy Head of the Russian Foreign Ministry Andrei Rudenko told RIA Novosti.

Indonesia, Russia closely connected at regional and global levels — MFA. According to First Deputy Foreign Minister of Indonesia Anis Matta, Jakarta and Moscow have long been cooperating in various fields.

Major Russian city to ban migrants from driving cabs. St Petersburg is set to bar many foreign nationals from courier and taxi work until 2026.

Indonesia and the European Union are set to finalize a free trade agreement by the end of June 2025 after nearly a decade of negotiations. The deal aims to remove tariffs on 80 percent of Indonesian goods, boosting market access for key products. Chief Economic Minister Airlangga Hartato stated the agreement underscores a mutual commitment to resolving outstanding issues.

The President of Poland, Andrzej Duda, made an official visit to Malaysia, meeting with Prime Minister Anwar Ibrahim to strengthen bilateral ties. Both leaders agreed to promote balanced trade, enhance cooperation in the agri-food sector, and pursue joint initiatives in digital transformation and renewable energy.
